I. CALL TO ORDER:

Mayor Murray called the workshop to order at 6:46 pm.

II. COUNCIL BRIEFING:

Town Manager Willis told Council the shrimp season was bad this year therefore, no shrimp was coming across the dock. He said the swordfish boats were having a good year and were using the docks. Mr. Willis said he was considering putting out a bid for someone to run the seafood market. He also said they would be removing the two sunken boats from the docks and told council the sunken house boat situation was currently in court.

Town Manager Willis also discussed the Town's already established mooring field, storm water in Duck Blinds and landscaping at the Madrid Avenue pond. He said some vandalism had occurred at the Cypress Wetlands to include signs stolen, eight to ten panels kicked out, and damage to a display box. He discussed the three branding charettes and said findings from those charettes should be available in about three weeks, an offer has been made on the two concrete buildings at the port and they were awaiting word from the Port's Authority on the possible sale. Mr. Willis said there is also interest in another part of the property. He discussed the proposed local option sales tax and said this would be the best option for the town. Mr. Willis said renovation work on the Police Station has begun, the demolition permit has been issued for the Parker's

gas station and that some trees would be cut at that site. Mr. Willis said the Ribaut Road sewer project was underway, the only thing left to do at Hillside Court is laying the asphalt and he felt the best solution for the skateboard park was to schedule a time for bikers to use the park.

Council discussed the skate park issue and decided to allow bikers to use the park on Saturdays and Sundays during the hours of 2:00 pm until 4:00 pm on a six month trial basis.

III. REVIEW AGENDA FOR THE FEBRUARY 12, 2014 COUNCIL MEETING

Town Manager Willis reviewed the agenda for the February 12, 2014 meeting. He read Ordinance 2014-1 by title and explained this ordinance was discussed at the preceding public hearing.

Town Manager Willis told Council they would be asked to choose a date for the upcoming retreat at next week's meeting. He also asked for topics they would like to discuss at the retreat.

Town Manager Willis said he would speak with Dean Moss, the Town's representative on the Spanish Moss Trail Board about the trail connecter. He explained the County was working with the Department of Natural Resources concerning the Fort Frederick boat landing.

Mayor Murray discussed a class he had attended concerning ways used by gang members to mark their "territory".
