Council Member Ashmore made a motion to approve the minutes from the Public Hearing of May 4, 2022, the minutes from the Council Workshop of May 04, 2022, the minutes from the Special Meeting of May 11, 2022, and the regular Council Meeting of May 11, 2022. Council Member Phillips seconded the motion. The motion was carried by a unanimous vote.

## IV. PRESENTATION:

## A. Capital Project Sales Tax- Eric Claussen

Beaufort County representative, Eric Claussen presented the Capital Project Sales Tax.

#### V. COUNCIL BRIEFING:

A permit has been received to start the project of the Spanish moss trail to be incorporated in Port Royal. There is additional funding that needs to be allocated to help with the completion of the project.

Several boats have been relocated and others have been anchored off. The removal of some of the boats are also still in the progress of being removed.

#### VI. FIRST READING:

A. Ordinance 2022-8. An ordinance amending Chapter 2 Administration, Article VI Boards, Committees, Commissions, Etc., Division 4 Parks and Recreation Commission, Section 2-294 Powers and Duties in the Code of Ordinances of the Town of Port Royal, South Carolina.

Council Member Ashmore made a motion to approve the first reading of Ordinance 2022-8, Council Member Owens seconded the motion. The motion was carried by a unanimous vote.

B. Ordinance 2022-9. An Ordinance approving the negotiation, execution, and delivery of intergovernmental agreements by and between Beaufort County, and the Town of Port Royal regarding the collection and distribution of impact fees for Parks and Recreation, Transportation, and library facilities; and other matters relating thereto.

Council Member Ashmore made a motion to approve the first reading of Ordinance 2022-9, Council Member Owens seconded the motion. The motion was carried by a unanimous vote.

C. Ordinance 2022-10. An ordinance to authorize the Town Manager to convey excess real property to facilitate construction of sidewalks within the Town described as Beaufort County Tax District 110, Map 10, Parcel 385 and 102 (Approximately 100 ft. on 13<sup>TH</sup> street).

Council Member Ashmore made a motion to approve the first reading of Ordinance 2022-10, Council Member Owens seconded the motion. The motion was carried by a unanimous vote.

#### VII. SECOND READING:

A. Ordinance 2022-1. An ordinance annexing to the Town of Port Royal approximately 1.51 acres of real estate located in Beaufort County described as Beaufort County Tax District 100, Map 33A, Parcels 254, 404, and 406. (LOCATED AT 32 and 34 Savannah Hwy).

Council Member Owens made a motion to approve the second reading of Ordinance 2022-1, Council Member Ashmore seconded the motion. The motion was carried by a unanimous vote.

B. Ordinance 2022-2. An ordinance to zone approximately 1.51 acres of real estate located in Beaufort County described as Beaufort County Tax District 100, Map 33A, Parcels 254, 404, and 406. In Beaufort County to be zoned as T4UC.

Council Member Ashmore made a motion to approve the second reading of Ordinance 2022-2, Mayor DeVito seconded the motion. The motion was carried by a unanimous vote.

C. Ordinance 2022-4. An ordinance to amend as follows Section 1 of Ordinance 2021-23 to provide for the levy of taxes for ordinary town purposes in the Town of Port Royal, South Carolina, for the fiscal year beginning July 1, 2022, and to provide for the expenditures thereof.

Council Member Ashmore made a motion to approve the second reading of Ordinance 2022-4, Council Member Owens seconded the motion. The motion was carried by a unanimous vote.

D. Ordinance 2022-5. An ordinance to approve the Court Department Budget for the fiscal year beginning July 1, 2022.

Council Member Owens made a motion to approve the second reading of Ordinance 2022-5, Council Member Ashmore seconded the motion. Council Member Phillips recused himself from the vote. The motion was carried by a vote of three.

E. Ordinance 2022-6. An ordinance amending Chapter 15, Offenses and Miscellaneous Provisions, Section 26, Fraudulent Checks, etc., of the Code of Ordinances of the Town of Port Royal, South Carolina, to update Terms and Jurisdiction.

Council Member Owens made a motion to approve the second reading of Ordinance 2022-6, Council Member Ashmore seconded the motion. The motion was carried by a unanimous vote.

A. Resolution 5-22. A resolution of the Town of Port Royal, South Carolina, Town Council to support Buoy "P" as a continued structural buoy.
